NOTICE OF PUBLIC HEARING
VILLAGE OF WAPPINGERS FALLS**

NOTICE IS HEREBY GIVEN that the Board of Trustees of the Village of Wappingers Falls will conduct a PUBLIC HEARING on the 11th day of July, 2018, at 7:00 p.m. at the Village Hall 2582 South Avenue, Wappingers Falls, New York, at which time all parties in interest and citizens shall have an opportunity to be heard as to whether the Board of Trustees of the Village of Wappingers Falls shall adopt a proposed Local Law entitled "Local Law No.1 of the Year 2018.

PLEASE TAKE FURTHER NOTICE that the purpose and intent of the proposed Local Law is to establish (1) “No Parking Here to Corner” zones pursuant to Section 143-34 of the Village Code, and more particularly described in Schedule XXIV, Section 143-62 and (2) “Parking Prohibited at All Times” zones pursuant to Section 143-18 of the Village Code and more particularly described in Schedule XII, Section 143-50 of the Village Code.

BE IT ENACTED by the Board of Trustees of the Village of Wappingers Falls, as follows:

Section 1:

- a) The purpose of this Local Law shall be to establish “No Parking Here to Corner” zones under Section 143-34 of the Village Code at the following locations:
 - i. On the eastern side of Goring Place between Maple Street and Veatch Street; and
 - ii. On the northern side of Church Street between Hillside Avenue and Downey Avenue; and
 - iii. On the western side of South Mesier Avenue between East Academy Street and Prospect Street.

Section 2:

Section 143-62. Schedule XXIV: No Parking Here to Corner shall be amended as follows:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
i. Goring Place	East	Maple Street
ii. Church Street	North	Hillside Avenue
iii. South Mesier Avenue	West	East Academy Street

Section 3:

This Local Law shall also establish “Parking Prohibited at All Times” zones under Section 143-18 of the Village Code at the following locations:

- i. On the southern side of Maple Street at the intersection of Goring Place; and
- ii. On the southern side of West Street between West Main Street and Roy Avenue.

Section 4:

Section 143-50 Schedule XII: Parking Prohibited at All Times shall be amended as follows:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
i. Maple Street Place	South	Intersection of Goring
ii. West Street Street to	South	From West Main Roy Avenue

Section 5:

This Local Law as proposed has been determined to be a Type II Action pursuant to the regulations of the New York State Department of Environmental Conservation promulgated pursuant to the State Environmental Quality Review Act (“SEQRA”), which regulations state that Type II Actions shall not have a significant adverse effect on the environment.

Section 6:

This Local Law shall take effect immediately.
