The following Contract is the rules and regulations:

1. The Village Recreation Department is not responsible to supply tables, chairs or tents.
2. The Village Recreation Department is not responsible for lost or stolen property or accidents during set up or throughout the duration of the fair.
3. Rental space is to be paid in full with the return of the contract.
4. Each rental space dimensions are 10' x 10'.
5. Renter is responsible for cleanup of their area at the end of the festival.
6. The event is rain or shine. Therefore, a tent is not necessary but recommended.
7. All applications will be reviewed & approved by the Recreation Committee. Attached hold harmless agreement must be signed and returned with the application.
8. All food vendors must have a Health Food Permit from Dutchess County.
9. **Electricity is not available.**
10. Vendors are responsible for cleanup of their space at the end of the festival.
11. This is a family event. Vendors are asked not to vend violent or grouse goods.
12. If you are responsible for collecting NYS sales tax it will be your responsibility to hold the necessary sales tax permit.

FOOD VENDORS: VENDORS SERVING FOOD OR DISTRIBUTING FOOD SAMPLES WILL BE REQUIRED TO OBTAIN A FOOD PERMIT FROM DUTCHESS COUNTY DEPARTMENT OF HEALTH (845) 486-3400. FAILURE TO HAVE THE PROPER FOOD PERMIT COULD RESULT IN A FINE OF UP TO \$2000 AND BEING REMOVED FROM THE EVENT. PLEASE NOTE THAT YOU SHOULD GIVE YOURSELF ENOUGH TIME TO APPLY AND RECEIVE YOUR PERMIT BEFORE THE EVENT. YOUR PERMIT SHOULD BE DISPLAYED IN AN AREA WHERE IT CAN BE CLEARLY SEEN.
