The following Contract are the rules and regulations:

1. The Village Recreation Department is not responsible to supply tables, chairs or tents.
2. The Village Recreation Department is not responsible for lost or stolen property or accidents during setup or throughout the duration of the fair.
3. Rental space is to be paid in full with the return of the contract.
4. Renter is responsible for cleanup of their area at the end of the festival and removal of bulk debris (i.e. boxes)
5. The event is rain or shine. Therefore, a tent is not necessary but recommended.
6. Attached hold harmless agreement must be signed and returned with the application.
7. All food vendors must have a Health Food Permit from Dutchess County.
8. **Electricity is not available.**
9. No Counterfeit or bootlegged items permitted.
10. This is a family event. All items should be appropriate for all ages.
11. If you are responsible for collecting NYS sales tax it will be your responsibility to hold the necessary sales tax permit.

FOOD VENDORS: VENDORS SERVING FOOD OR DISTRIBUTING FOOD SAMPLES WILL BE REQUIRED TO OBTAIN A FOOD PERMIT FROM DUTCHESS COUNTY DEPARTMENT OF HEALTH (845) 486-3400. FAILURE TO HAVE THE PROPER FOOD PERMIT COULD RESULT IN A FINE OF UP TO \$2000 AND BEING REMOVED FROM THE EVENT. PLEASE NOTE THAT YOU SHOULD GIVE YOURSELF ENOUGH TIME TO APPLY AND RECEIVE YOUR PERMIT BEFORE THE EVENT. YOUR PERMIT SHOULD BE DISPLAYED IN AN AREA WHERE IT CAN BE CLEARLY SEEN. IF YOU HAVE A PERMIT FOR YOUR CURRENT LOCATION, YOU MAY BE REQUIRED TO OBTAIN A ONE DAY EVENT PERMIT, SO PLEASE CONTACT THE DEPARTMENT OF HEALTH.
