This Contract is subject to the following regulations:

- Rental Space is to be paid in full with return of contract.
- Rental Space is under the control of the Village of Wappingers Falls Recreation Department
- Each Rental Space shall be 10' x 10'
- The space to be occupied under the terms of this lease must be operating by 11:00 AM on the day of event and remain in place until the close of the event at 5:00 p.m.
- Renter is responsible for cleanup of their area at the end of the festival.
- Village of Wappingers Falls Recreation Department will not be responsible for any accidents, lost or stolen property during set up or throughout the duration of the fair.
- All food vendors shall hold the necessary permits. Grounds will open for vendor setup at 9:00 AM on the day of the event.
- This event will be held rain or shine although a tent is not necessary it is highly recommended for appeal and safety from sun or rain.
- The Recreation Department does not supply tables, chairs, or tents.
- If you are required to collect NYS sales tax you are responsible for holding the necessary NYS sales tax permit.
