LOCAL LAW NO. 1 FOR THE YEAR 2016

A Local Law entitled Local Law No.1 for the year 2016 amending section 148-35 of the Code of The Village of Wappingers Falls.

SECTION 1: LEGISLATIVE INTENT

The Village Board of Trustees for the Village of Wappingers Falls and the Board of Water Commissioners are desirous of amending section 148-35 of the Code of the Village of Wappingers Falls as it relates to Backflow Prevention.

SECTION 2: TEXT

Section 148-35 F (1) (b) and 148-35 F (2) (b) are hereby amended so as to replace the word “single-check” in each section with the word “double check”.

Section 148-24 is hereby removed, omitted and of no further force and effect.

All other portions of Section 148 of the Code of The Village of Wappingers Falls shall remain the same and are unaffected by this local law.

This local law shall become effective immediately.
